Accreditation of trainers Independent trainer, trainer associated with a training institution

Membership in the OAB-UK Commission (accreditation) is more than just a title. It's a stamp of approval that verifies the international status of beneficiaries (training institutions, trainers, training programs and examinations). It enables them to issue international certificates to participants in accredited training courses and international examinations. The Commission plays a crucial role in ensuring the credibility and reliability of our certified members, instilling confidence in their global standing.

Types of international accreditation for trainers

1. **Independent trainer:** The trainer who conducts the training is accredited independently of any training centre after he achieves the OAB-UK standards for accreditation of trainers. He is granted membership as an international trainer certified by the OAB-UK Corporation according to the rank that suits his qualifications and experience, and he has the right to submit a request to issue certificates to the participants in the conducted courses. It was approved directly through his verified account on the Oxford website.



2. Trainer associated with an accredited training centre: He is the trainer who is nominated for





accreditation through a training centre accredited by the OAB-UK Authority after he achieves the OAB-UK standards for accrediting trainers. He is granted membership as an international trainer certified by the OAB-UK Authority according to the rank that suits his qualifications and experience, and his verified account on the Oxford website is linked to the centre's name. One or more accredited training sessions and a request to issue certificates for participants in the certified courses provided by it are submitted through the account of the accredited training centre.



The trainer's international accreditation means he meets the OAB-UK Board (OAB-UK) standards and has international status and reliability. This allows him to approve training programs and obtain many electronic services and benefits through the Oxford International Academy platform, leading to the issuance of international certificates for participants in the approved training courses.

The trainers' accreditation is documented through the OAB-UK Authority's website through a unique account for the international trainer that visitors to the site can see, establishing the trainer's international accreditation number, the accreditation certificate, and the approved training courses for the independent trainer or associated with a training centre, as well as documenting the certificates of participants in training programs and others.

Following approval by the Accreditation Commission, independent trainers will receive years of accreditation consistent with the OAB-UK Professional Membership Package once the accreditation



package is purchased, in addition to their accredited training programmes. Non-independent trainers associated with accredited training centres follow the training centre accreditation package.

Procedures for applying for independent trainer accreditation

All procedures are done electronically (online)

The OAB-UK Corporation's international accreditation procedures, which are global standards, confirm the reliability of its accredited members and ensure the quality of training and the credibility of its international certificates.

- 1. Open an account in the name of the Trainer by registering on the Oxford website through the Link.
- Log in through the trainer's account on the website (the trainer's name appears on the left of the top bar), fill out the accreditation application and attach the necessary documents through <u>Link</u>. (The application for accreditation does not open until after registering on the Oxford website)

Please Choose "Independent Trainer" if the trainer is not associated with any training centre accredited by the OAB-UK.

The training packages and their number are carefully determined (at least one package or according to the package chosen), as training packages can be added at any time from the independent trainer's account when needed.

- 3. The application will be presented to the accreditation committee for approval, and according to the attached documents, the trainer's rank will be determined.
- 4. If approved, an invoice will be issued that includes the fees for issuing the trainer's accreditation certificate and an accreditation certificate for each training package he wishes to adopt (\$50 for each certificate, one-time only). The trainer will be informed to pay the invoice to complete the accreditation procedures.
- 5. Prepare the certified trainer page and accreditation file on the Oxford platform (please prepare the necessary documents to approve the training packages)
- 6. Providing the trainer with an accreditation logo so he can use it with a link to his page on the Oxford website for advertising courses
- 7. From the trainer's account on the Oxford platform, the accredited trainer submits requests to approve training portfolios for the courses he wishes to submit for approval so that the trainer's courses appear on his page with the accreditation certificates, and the trainer can publish his upcoming classes on the schedule of the forthcoming courses on the Oxford website.

Documents required for trainer accreditation

Documents required when applying for international trainer accreditation from the OAB-UK Commission

- 1. Personal photo of the Trainer (recent)
- 2. A copy of the trainer's passport or ID card
- 3. A copy of academic qualifications certificates
- 4. A copy of the certificates of attendance for the courses attended by the trainer
- 5. CV (in Arabic and English) includes the Trainer's courses and the Trainer's training activities.

* The OAB-UK Commission does not accredit courses in modern medicine, except for some public health and clinical courses that do not require participants to obtain a university degree in modern medical sciences.

Note: Some fields overlap and converge to cover all the training fields and their names according to the countries. The closest field is chosen, with the possibility of selecting more than one field according to what the training institutions and trainers see fit, provided that the training fields do not exceed three fields as a maximum.

Documentation of trainer accreditation from OAB-UK

After submitting the trainer's accreditation request and having it approved by the accreditation committee, an electronic page is designed on the Oxford website that documents the international trainer's credentials, including the international trainer's number, his certificate of accreditation, the approved training courses he provides, and others. This leads to issuing certificates to participants in the approved training programs.

Procedures for submitting a request for accreditation of a training package

All procedures are done electronically (online)

- After the trainer is accredited by the OAB-UK Authority and his international accreditation is documented on the Oxford website, he has the right to organise the training packages (the training program/course) by filling out the "Training package Accreditation Request" after logging into his account on the Oxford platform and attaching the training package axes form through <u>Link</u>.
- 2. The application is presented to the Accreditation Committee for approval, and any necessary amendments are made, including the exam, if the course organiser wishes to approve it and add it to the Oxford website.
- 3. If approved, an invoice will be issued, including the fees for issuing a training package accreditation certificate (\$50 for each certificate, one time only) and sent to the certified trainer. After paying the invoice, the accreditation procedures will be completed (an invoice is not issued if the package/course is within the framework of the accreditation package that has been previously determined)
- 4. The training course represented by the training package appears among the approved training courses in the accreditation file of the approved trainer organising the training package.

Procedures for issuing certificates to participants

All procedures are done electronically (online)

Training certificates accredited by the OAB-UK Authority are available on the <u>International certification</u> website.

It has an international serial number International Serial Number of Training Certificate ISNTC

After the training package (program/training course) is approved by the OAB-UK Authority and its international accreditation is documented on the Oxford website, the package organiser can submit a request to issue certificates to participants in the approved training programs after the package organiser logs into his account on the Oxford website, which goes through the following stages:

- 1. Submit a request for issuance of certificates from the course organiser when the course begins.
- 2. An electronic invoice is issued and sent to the course organiser's email.
- 3. The course organiser pays the invoice within three days using one payment method that suits him, as mentioned in the invoice.
- 4. Certificates are issued according to the standards of the OAB-UK Corporation and are downloaded on the international certificates website before the end of the course
- 5. An electronic document containing the participants' names and the international number of each



participant's certificate is sent to the course organiser's email at an appropriate time before the end of the course.

- The course organiser (or certificate holder) can enter the international certificate number in the space provided on the <u>International certification website</u>.
 He can download the certificates as images or PDFs, remove them from colour paper, and deliver them to those entitled to them.
- 7. The certificate's website also includes the training course/portfolio topics accredited by the OAB-UK Commission, a guide and a reference for the training course. The training course topics can be downloaded in PDF format and extracted on paper.
